

EWA at EXPOAPA 2025



The European Water Association (EWA) was proud to be present at the **EXPOAPA 2025** Regional Water Forum "Danube – Eastern Europe", held from 23 to 25 June 2025 in Bucharest, Romania. This high-level regional event, organised by <u>Asociatia Română a Apei</u> (Romanian Water Association), brought together key stakeholders from across Europe to exchange knowledge and foster collaboration in the water sector.

Arthur Guischet, representing the European Water Association, played an active role in several key moments of the event. On Monday, he had the honour of delivering opening remarks, following Ilie Vlaicu, President of Asociația Română a Apei, and Roxana Minzatu, Executive Vice-President of the European Commission, in charge of Social Rights and Skills, Quality Jobs and Preparedness.

EWA visits WVER Wastewater Treatment Plant in Aachen-Soers



On July 8th, EWA Secretary General Arthur Guischet and EWA Communications Officer Carolyne Herten had the opportunity to visit the Aachen Soers wastewater treatment plant, managed by **WVER Wasserverband Eifel-Rur.**

Aachen, like many other cities, is dealing with challenges posed by climate change. While overall precipitation levels have remained stable, the patterns of rainfall have altered significantly. This necessitates effective management of both stormwater and periods of drought. Additionally, the wastewater treatment plant faces a significant **recruitment challenge** within the sector and they're preparing for **changes due to the revision of the UWWTD**.

Dr. Frank Jörrens and Hermann Stepkes gave us a great tour of the plant and showed us some of its unique features. The facility includes: **Six retention soil filters**, a **fourth treatment stage using an ozone system**

To tackle the staffing issue, **WVER** set up a training center where young people can train to become mechatronics engineers, electronics technicians for industrial systems, or wastewater tech specialists. It's a fantastic opportunity for students to gain hands-on experience and move straight into a job with lots of career growth. For the plant, it means having well-trained and motivated staff ready to step in.

1. 2025 European Water Resilience Strategy

The European Commission published the 2025 European Water Resilience Strategy and the Recommendation on Water Efficiency First:

The EU Water Resilience Strategy, adopted in June 2025, aims to enhance the EU's ability to manage water-related challenges and ensure a sustainable water supply. The strategy focuses on restoring and protecting the water cycle, building a water-smart economy, and ensuring access to clean and affordable water for all. It also seeks to strengthen the EU's water industry and promote international cooperation on water resilience.

EWA is pleased with the Strategy and will monitor and support its implementation in the coming weeks and years to help make it the success we need to ensure Clean Water for Europe: Quality, Safety, and Sustainability for All.

2. European bathing water quality in 2024

The assessment and the interactive map, put together by the European Environment Agency (EEA) in cooperation with the European Commission, highlight where swimmers can find well managed bathing sites in Europe. The assessment inspects water suitability for bathing, focusing on monitoring bacteria which can cause potentially serious illnesses.

Overall, over 22,000 bathing water sites across all 27 EU Member States, plus Albania and Switzerland were assessed. In five countries — Cyprus, Bulgaria, Greece, Austria and Croatia — 95% or more of bathing waters were of excellent quality. Only 1.5% of the EU's bathing waters were found to be of poor quality.

The quality of coastal bathing waters is generally better than that of rivers and lakes. In 2024, around 89% of coastal bathing waters in the EU were classified as excellent, compared with 78% of inland bathing waters.

3. French State liable for death caused by toxic algae

A French court on Tuesday June 24th ordered the state to compensate the family of a 50-year-old man who died in 2016 during a run after inhaling poisonous gas emitted by rotting green algae piled along the country's western coast.

The Nantes appeals court found France liable for the death of Jean-Rene Auffray, citing its "negligence" in enforcing environmental regulations to protect its waters and prevent toxic green algae blooms.

For more than five decades, tons of green algae have washed up annually on Brittany's beaches in western France, releasing hydrogen sulphide gas as it rots — a toxin that can prove deadly in high concentrations.

The problem of toxic algae bloom stems from the region's farms

4. Italian Court Ruling Sentences 11 Executives to Jail for PFAS Pollution

After four years and 133 hearings, the Court in Vicenza has delivered a historic verdict in one of Europe's most serious environmental crime cases: the intentional contamination of water sources with PFAS (per- and polyfluoroalkyl substances) in the Veneto region. The Miteni plant, which was located in Trissino and is now closed, had been leaching PFAS into the surrounding groundwater, which subsequently ended up in drinking water. This led to over 350,000 citizens from 21 local towns being exposed to the substances.

- 11 former managers and employees of the chemical company Miteni—including figures connected to multinational giants Mitsubishi and ICIG—have been sentenced to a combined 141 years in prison for serious offences including:
- · Intentional environmental disaster
- · Water poisoning
- Fraudulent bankruptcy

Only one charge, related to unauthorized waste management, was time-barred.

5. EUR 250 million available for new projects on security research

A new call for projects under the Civil Security for Society cluster of the Horizon Europe fund is being launched on 12 June 2025. With an estimated budget of nearly EUR 250 million, the call for proposals touches upon topics such as EU external border management, protection of infrastructure, cybersecurity, disaster resilience, the protection of EU citizens against crime and terrorism, as well as strengthened security research and innovation.

6. EIB commits 15 billion euros to protect EU's water resources

A central pillar of the Water Resilience Strategy is the relaunch of investment, with a key role assigned to the European Investment Bank (EIB). On the 4th of June, the EIB committed to mobilising 15 billion euros over the next three years to reduce pollution, prevent waste, and support innovative businesses in the sector.

7. European Commission Appoints New Director-General for Environment

The European Commission has decided to appoint Eric Mamer as Director-General for the Directorate-General for Environment (DG ENV). This department leads the European Commission's development and delivery of environmental policy that protects, preserves and improves the environment, for present and future generations, while promoting sustainable development. The date of effect of this decision was the 1st of July.

8. Commission strengthens Europe's chemical industry

The European Commission presented an Action Plan for the Chemicals Industry to strengthen the competitiveness and modernisation of the EU chemical sector. The Action Plan addresses key challenges, namely high energy costs, unfair global competition, and weak demand, while promoting investment in innovation and sustainability. The Action Plan is accompanied by a simplification omnibus on chemicals – the sixth that the Commission has presented in this mandate so far – to further streamline and simplify key EU chemicals legislation, alongside a proposal to strengthen the governance and financial sustainability of the European Chemicals Agency (ECHA).

9. Upholding the Law

The European Union is constitutionally designed as a Union of Law. According to the Treaties (Treaty on European Union, Treaty on Functioning of the European Union), Member States are obliged to comply with EU legislation adopted by the legislator (European Parliament and Council), and the Commission has the right and the obligation to scrutinise such compliance and where appropriate take legal action.

In recent weeks, the European Commission initiated a series of infringement procedures concerning various water-related issues. These range from the correct transposition of the Drinking Water Directive to matters related to water permits and the implementation of the Waste Framework Directive. The following countries are involved:

Bulgria, Greece, Spain, the Netherlands, Portugal, Lithuania, Germany, Poland, Slovakia, Italy, and Romania.

The Commission is also closing 64 cases where the issues with the Member States concerned have been solved. In these cases, the Commission does not have to pursue the infringement procedure further.

European Parliament, water-related Parliamentary questions Members of the European Parliament show a regular interest of water issues in their Parliamentary questions. In the period between 1 June and July 31 2025, 48 water-related questions were tabled, from the Water Resilience Strategy, to water reuse, PFAS and many more.
