## Survey on current monitoring practices across Europe



Urban water systems are facing increasing pressures from diverse and emerging pollutants, while striving to establish resilience and sustainable water management in our cities.

Across Europe, various initiatives and plans aim to reduce pollution and ensure access to clean water for all citizens. These plans require a great amount of data to identify problems, design solutions, and assess the impacts of pollution reduction actions.

However, current water quality monitoring methods and technologies are limited in scope, often require significant financial investments, and are labour-intensive.

Over the next four years, the EU-funded [Urban M2O project](#) will integrate sensor technologies with AI and digital tools to provide stakeholders and decision-makers with the necessary data and information to plan, design, and implement pollution control actions at the city-wide scale. To ensure that Urban M2O solutions can successfully support the ambitions of the European water sector, we need to better understand current practices and needs.

**If you are involved in monitoring water quality in any urban water matrix** (drinking water, wastewater, stormwater, surface waters, treated wastewater, groundwater, etc.), we would like to hear from you. We have prepared a survey to gather information about past and current monitoring activities, the monitored parameters, the resources invested (financial, workforce), and how the collected data are utilised. We are not looking at research activities, but at the everyday monitoring carried out by utilities, consultants and public authorities.

The responses will help us tailor the development of the URBAN M2O tools to meet the needs of the water sector across Europe. ### 1. Water Sector Warns Against EU Legislative “Simplification”

In a letter addressed to several commissioners, Aqua Publica Europea, EurEau, Water Europe, the European Water Association, and AquaFed defend the current regulatory framework and call for its proper implementation rather than amendment. The texts in question constitute the “backbone” of the water resilience strategy presented by the Commission in June.

## 4. European Water Academy Launch 2026: Survey Insights

The upcoming European Water Academy (EUWA) is one of the pillars of the European Water Resilience Strategy. According to nearly half of the 127 respondents to a recent survey, EUWA should focus on technical skills for water operators. Concrete ideas about the academy will take shape during the European Water Resilience Forum which will be held on December 8 in Brussels. The target date for the launch of EUWA is set for June 2026.

## 5. Dutch PFAS Pesticide Use Soars 67%, Groundwater at Risk

The use of PFAS pesticides in agriculture and horticulture in the Netherlands has increased by about 67 percent over the past three years. This is shown in a new report from the Dutch research and advisory agency CLM on the use of PFAS-containing pesticides and the risks for groundwater, soil and drinking water.

## 6. 2025 EU Climate Progress: Strengthening Competitiveness

Every year, the Commission publishes the EU Climate Action Progress Report: an annual report on progress towards the EU's emission reduction targets. The report covers actual (historic) emissions and projected future emissions for the EU as a whole and for every EU Member State. It also includes information on different climate policy areas, EU legislative progress, climate finance and adaptation.

On October 21st, the Council approved conclusions on the European water resilience strategy. The conclusions reflect a unified call from environment ministers for stronger, coordinated action across Europe to address the growing water challenges facing the continent and regions within the EU.

## 8. Ombudsman Flags Maladministration in Commission's Urgent Legislation

European Ombudswoman Teresa Anjinho has found a number of procedural shortcomings in how the European Commission prepared several legislative proposals that it considered urgent. Taken together the shortcomings amounted to maladministration.

The findings are based on three separate complaint-based inquiries that examined the extent to which the Commission applied the standard policy-making rules and procedures when preparing legislative drafts concerning corporate sustainability due diligence (Omnibus I), the Common Agricultural Policy (CAP), and countering migrant smuggling.

## 9. European Parliament, water-related Parliamentary Questions

European Parliament, water-related Parliamentary questions.

Members of the European Parliament show a regular interest in water issues in their Parliamentary questions. In the period between 1 September 30th, 2025, and November 27th, 2025, 33 water-related questions were tabled, from Water scarcity to Nitrate derogation and many more.

## 10. Upholding the law

The European Union is constitutionally designed as a Union of Law. According to the Treaties (Treaty on European Union, Treaty on Functioning of the European Union), Member States are obliged to comply with EU legislation adopted by the legislator (European Parliament and Council), and the Commission has the right and the obligation to scrutinise such compliance and where appropriate take legal action.

In recent weeks, the European Commission initiated a series of infringement procedures concerning various water-related issues. These range from the correct transposition of the Drinking Water Directive to matters related to water permits and the implementation of the Waste Framework Directive. The following countries are involved:

BULGARIA,  
LITHUANIA,  
MALTA,  
POLAND,  
PORTUGAL,  
SLOVAKIA,  
SWEDEN,  
AND the NETHERLANDS,

The Commission is also closing 95 cases where the issues with the Member States concerned have been solved. In these cases, the Commission does not have to pursue the infringement procedure further.

## 11. EU Revises Water Framework Directive in 2026

On December 3rd, the European Commission published its executive's RESourceEU plan which mentions a revision of the Water Framework Directive for the second quarter of 2026.

The Commission will review and revise the Water Framework Directive building on stakeholders' input and experiences in Member States, paying particular attention to simplification and the need to address potential bottlenecks, in order to promote circularity and access to critical raw materials in the EU, while protecting the environment and human health.
